Guidelines for SPOCs

Location: Spain

Disclaimer: The following are proposed guidelines and do not necessarily replace importance of medical advice / medical referrals.

SPOCs (Single Points of Contact) are expected to stay vigilant at all times while they're on the office premises.

Should the SPOCs suspect illness of any person within the Enzen premises, covering, but not limited to:

- 1. Enzen employee
- 2. Any contractor working within Enzen premises
- 3. Visitors / guests

They MUST to adhere to the following procedure:

- 1. Firstly, DO NOT PANIC!
- 2. Second, isolate the person.
 - a. Isolate the suspected / impacted person immediately into a separate room.
- 3. Immediately inform any of the following ERT personnel:

Instructions for the ERT across Enzen Spain

At Enzen, all resembling symptoms must be reported to the Emergency Response Team (ERT) members.

All ERT members are requested to follow the recommended procedure listed below:

- 1. Immediately report the case to the Pathogen Response Governance team
- 2. Ensure that the impacted person is comfortable during isolation. Provide them with warm water, tissues, etc.
- 3. Cordon off / sanitise the work area(s) of the impacted person (desks, chair, laptop, etc.).
- 4. Check temperature only with the help of a non-contact infrared / laser thermometer. This is available with the Admin team at your respective locations.
- 5. Should any of following symptoms noticed, the ERT team must refer to the relevant authorities for further advice (*):
 - a. Respiratory symptoms
 - b. Fever
 - c. Cough
 - d. Shortness of breath
 - e. Breathing difficulties

Recommended dos and don'ts for SPOCs and ERT members*

Spain

The Spanish Ministry of Health, Consumption and Social Welfare recommends:

- Frequent hand hygiene (washing with soap and water or alcoholic solutions), especially after direct contact with sick people or their surroundings.
- When coughing or sneezing, cover your mouth and nose with your elbow bent or a tissue.
- Keep a distance of about one meter with people who show signs of respiratory condition, such as coughing or sneezing.
- Avoid touching your eyes, nose and mouth, as the hands facilitate transmission.
- The general healthy population does not need to wear masks. Health professionals will indicate the use of masks in those situations in which it is considered necessary in each case.
- Improper use of masks can contribute to a shortage of them in those situations for which they are indicated.
- If you develop respiratory symptoms (fever, cough and feeling of shortness of breath), stay at home and contact the health services by telephone by calling 112. The health services will assess your state of health and the travel history and possible contact with cases of coronavirus.

Note: Under any and all circumstances, please refrain from:

- Providing medication to impacted person(s).
- Volunteering to lift / support the impacted person (s) without instructions from a competent authority (preferably a medical practitioner).
- Driving the employee / accompanying the employee until instructed to do so.
